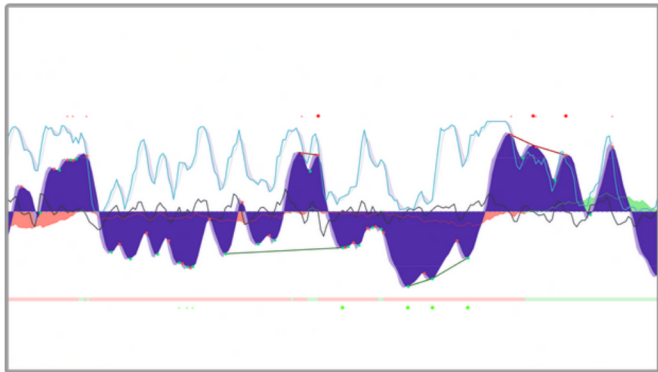
BitcoinTAF DETONATOR A™ - (DET A)

- RED JACKAL (RJ) - Very Powerful Bearish Signal
- Wale Flag- (WF) - Indicates Market Manipulation
- Blue Diamond - (BD)- Indicates Trend Reversal

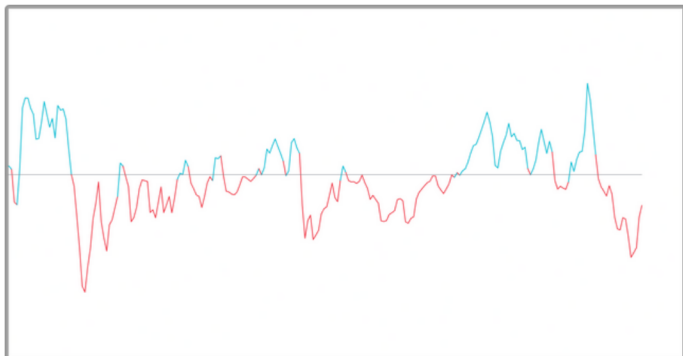


DETONATOR™B is a highly effective momentum oscillator and moves with the market trend. This is one of the go-to and most powerful indicators we use.

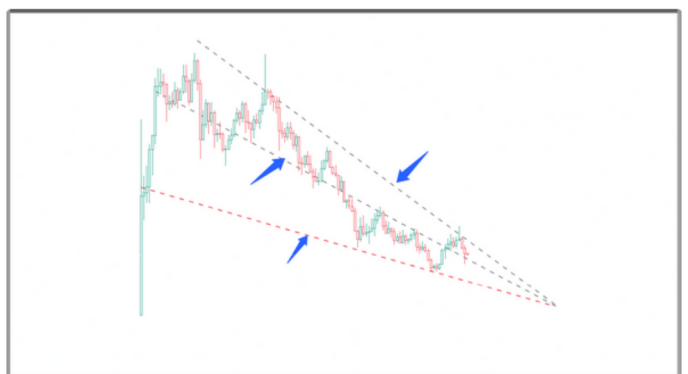

MARKET OVERVIEW





Cryptocurrency Medium Term Trade Report (MTT): 30 May- 02 June 2023

In this report, we are going to look at new and current MTT ALT coins that have the potential to spike vertically between 40% and 120%+. We will also look where BTC stands at the time of this report, and keep to our new MTT strategy. For best results, use the Elliott Wave Algorithm Report as a guideline for market direction together with this report.

OVERALL MARKET

As of this morning BTC had a retracement. The market is still mostly in a ranging consolidation and we keep patient. Most ALTS are primed to have a huge bullish run. Using trendlines are vital for our MTT analysis and shows clearly which time pivots are important. Trendlines with DETB & C tells us where market is and when to keep alerts ready.

Bitcoin (#BTC) MTT ANALYSIS

12 HOUR BTC

BTC is currently oscillating between 29739 and 25649 HPL Levels. Looking at the 12hr Falling Wedge pattern we broke the top TL of this pattern with a small 7% run over past week and resisted at exactly our 28126 HPL level. The trend still remains inbetween our DTM EMA and blue bull VWAP line. DETB does indicate a red dot for more correction. We still have support on top Falling Wedge T/L. Confluence points to a a breakout soon after correction.



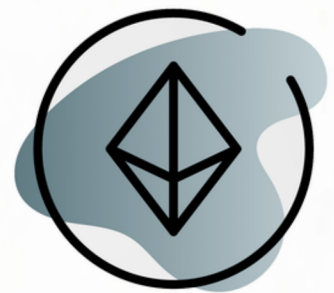

COIN SELECTION



Ensure you always use a stop loss to manage risk – this applies to all coins traded.

**1. #ASTR (WEB 3 - SMART CONTRACTS)**

Kucoin / GateIO / Kraken / Crypto.com

The trend still remains under the 12hr T/L as well as under the bottom HPL level. Huge bullish divergence formed on the DETB. More retracement to follow and I want to see support remain within the triangle. Patience here and we keep with strategy.

**2. #CHILIZ OR #CHZ (FINTECH - GAMING)**

KuCoin / Coinbase / Kraken / Crypto.com / GateIO

Trend still in the Bilateral Descending Triangle for CHZ as shown by the blue arrow. DETB still bearish momentum. I did note caution here last week. Should CHZ break downwards past the triangle I will concentrate on better moving assets.





3. #AXS(GAMING)



Coinbase / Kraken / Crypto.com

Trend managed to break through 12hr T/L with a 10% spike. Top of momentum with a red dot on DETB and correction. Will be good if we keep support on the T/L. Not at BOTTOM entry yet. We getting closer to VWAPS. Keeping alerts on here.



4. #COTI (Cross-chain Interoperability)



Coinbase / Kraken / Crypto.com

We have reached end of W triangle and had small 7% bullish move to BOTTOM entry. Keeping support on the T/L will be good. Still resisting here and correction due soon. Keeping to Entry strategy is vital. The next bottom of momentum will be a good bullish push. Patience here.





5. #LINK (Smart Contract Oracle Network)



Kraken / Crypto.com / Coinbase / Gemini / Uniswap

LINK still in major sideways consolidation on higher T/F. The trend still resisting against bottom entry and the 12hr T/L. Patience still with this coin. A definite clear break needs to happen with support before I will consider an entry here.



6. # EGLD (DEFI)



Coinbase / Kraken / Crypto.com

A GOLDEN DOT and break of T/L resistance for EGLD for 5%. Back at Bottom entry level. Correction incoming but EGLD does look strong for me. Golden dot does indication good incoming bullish movement. Might not happen immediately but patience will be worth it with this set-up.





7. #WOO (DEX)



KUCCOIN / UNISWAP / CRYPTO.COM / KRAKEN / PCS

As predicted a green dot DETB movement of 14% to just below BOTTOM level. Rejecting against W T/L and this still remains the point at which I will look for entries once this line is broken. Correction incoming but my alerts set on the entry levels as the next green dot on DETB will be good bullish push.



8. #SOL (DeFi)



Crypto.com / Coinbase / Kraken / Gemini

Nice bullish movement in SOL for 10% from BOTTOM entry to level 1. More importantly we are getting very close to find support on our VWAPs which is what we would like to see in all assets, Support on here will be good. Correction incoming but trend becoming bullish. Keep to levels.





9. #RNDR (DeFi)



Crypto.com / Coinbase / Kraken / Gemini

WINNER OF THE WEEK -Render remains very bullish and currently forming a bullflag with this weeks correction. Breaking this channel will ensure more bullish movement.DETB coming to a green dot with a very oversold STOCH. It's important to have alerts on and keep to levels with entries as well as stoploss.



10. #GRT (API)



KuCoin /Crypto.com / Coinbase / Kraken / GateIO

Good bullish run for GRT from BOTTOM to level 1 at 0.1277 for 14.48%. Trend looking strong and bullish. We have an incoming correction. I would like to keep support on the BOTTOM HPL level as well as 12hr T/L which we broke this week. Very close to finding support on VWAPS which will give a great bullish move. Sets alerts.





11. #KSM (PARACHAINS)



KuCoin /Crypto.com / Coinbase / Kraken

KSM managed to break the bilateral descending triangle top TL for a 8% run to just below level 1 - 26.99. In correction now and important to keep support on entry. Next green dot might have a good bullish run as indicated by the GOLDEN DOT on DETB.



12. #MANA (METaverse)



KuCoin /Crypto.com / Coinbase / Kraken / Uniswap

An 8% move from MANA to the BOTTOM level where we then resisted and printed RJ. In a correction now but looking at the bullish divergence and strong anchor waves we might see a good bullish movement after this. Keep alerts set on Bottom Entry.





13. #OG (NFT)



Gatelo / Huobi / MEXC

We are still remaining underneath the 12hr T/L and holding support on the W T/L. The newly printed GOLDEN DOT makes me patient with this coin. Support on ema as well as Bottom entry will be entry for me as a bullish move is signalled.



14. #RADIX - #XRD (DEFI)



KuCoin / Gatelo / MEXC

The trend broke the top T/L and keeping so far but a correction is happening with the red dot on DETB. I definitely will look for entry once we above BOTTOM level. STOCH still high and overbought. Caution here.



**15 . #APE (DAO)**

Coinbase / Gemini / Kraken / Crypto.com / Uniswap

APE did not manage to break the T/L from last report like I hoped. RJ send trend down and still in retrace. More patience here and I will report once this coin has turned around. Bottom level still remains entry and once again show why we need to stick T/L and indicator confluence. Lots of bullish divergences but still very bearish trend.

**16 . #PYR (Vulcan Forged – GAMING)**

Uniswap / Crypto.com / Coinbase

Bullflag retrace for PYR and we still didnt manage to break the top W T/L. Trend is now oscillating at BOTTOM entry level. We remain cautious until we have clear support on T/L's as well as DETB green dot confluence.



**17. #GALA (GAMING)**

Kraken / Crypto.com / Coinbase / Gemini

GALA V2 have been announced which could indicate the sideways move of the Trend. A 1 to 1 airdrop will happen which could be a good spike for GALA. We will asses the markets and wait for the new version launch before posting a new chart and give new posistions.

BINANCE US

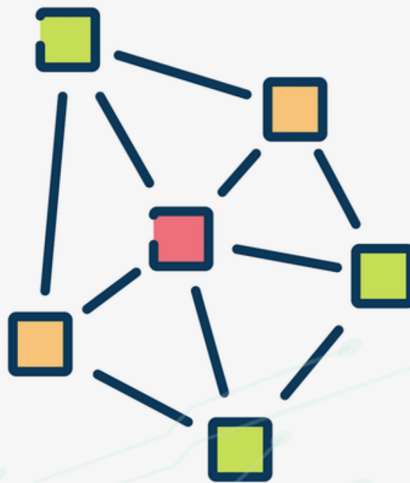

TERMINOLOGY

Limit Exposure or exit points

The term limit exposure means a trader could exit with 10%, 20%, or 30% depending on the setup of the trader. The trader then sells higher and buys in lower. - A strategy is having a balanced personal portfolio with a set number of a maximum of 5-10 large cap coins and a maximum of 5-10 smaller caps coins from Small Cap Big Moves. You do not need to trade 30+ coins to make a profit!
